Traffic Safety Commission Meeting Wednesday, October 16,

1. CALL TO ORDER. The meeting was called to order at 6:00 pm by Chief Mason.
2. ROLL CALL. Present: Commissioners Present: Bob Mason, Heather Chase, Kevin Crutsinger, Fred Evander, Mike Tweed. Gerald Fisher, absent. Others present: James Krysh-citizen, Ann Scheck-Press
3. MINUTES. The minutes of the June 19, 2024 meeting were submitted in the agenda packet. Evander moved to approve as submitted; Crutsinger seconded. Motion passed by all commissioners present.
4. VISITORS / PUBLIC COMMENTS.
 - 4.1. James Krysh wants to get involved but isn't sure how. Recorder Johnson confirmed there is an open position on committee.
5. STAFF REPORTS / PRESENTATIONS
 - 5.1. Traffic Data. Mason reviewed submitted data with commission. Included traffic accidents and statistics from June 11-October 10 2024. Discussion of hit and run accidents. Mason shared that city has received traffic grants for enforcement for now through September 2025. \$20,000 for 5 different programs including seatbelt enforcement, pedestrian crosswalk safety, distracted driving, speed, impaired driving. Part time employee will work on this traffic enforcement grant.
 - 5.2. Extra light at Central High School Crosswalk. Mason read report from Public Works director Fisher. Fisher submitted request to Pacific Power but has not heard back from them on specific date. Light has not been installed currently.
 - 5.3. Speed reduction on Gun Club Rd. Mason read Fisher's report. Fisher is waiting for jurisdictional transfer of roadway to be complete before can submit a speed request to ODOT. Waiting on Polk County PW and Polk County Commissioners.
 - 5.4. Curb painting on S 4th and 7th St. Mason read Fisher's report. Thermo plastic striping installed on south leg of 7th and Monmouth. Winding down due to wet weather. Williams and Ash complete and now an all way stop. Krysh had questions about the stop that were addressed by Evander and Mason.
 - 5.5. Evander addressed temporary crosswalks as part of Central Talmage Plan to make area more pedestrian friendly. ODOT agreed to temp crosswalks as a test. Counted for 18 hour period , 728 crossings total in that time. Feedback from commission on crossing near Les Schwab. City now has good data to show ODOT. Would need a refuge island to move forward and approval from ODOT. Questions about refuge island at Central crosswalk. This is up to ODOT.
6. ACTION / DISCUSSION ITEMS.
 - 6.1. Communications.
 - Sept 19 message via Indy Works about stalled car. Mason will take under advisement.
 - Email from Lee Neilson. Concerned about speeding on Mooney St. Discussion. Need more information.

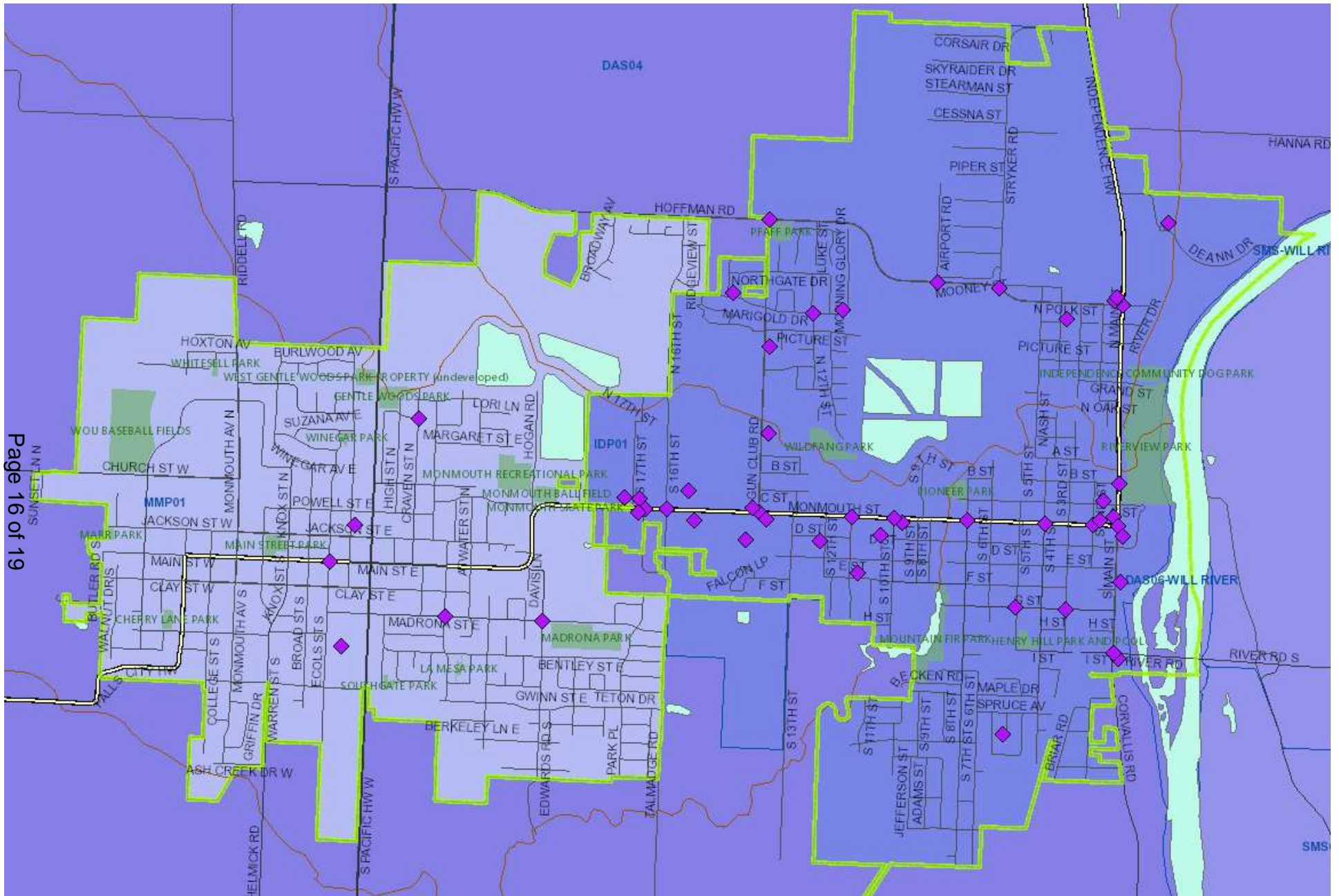

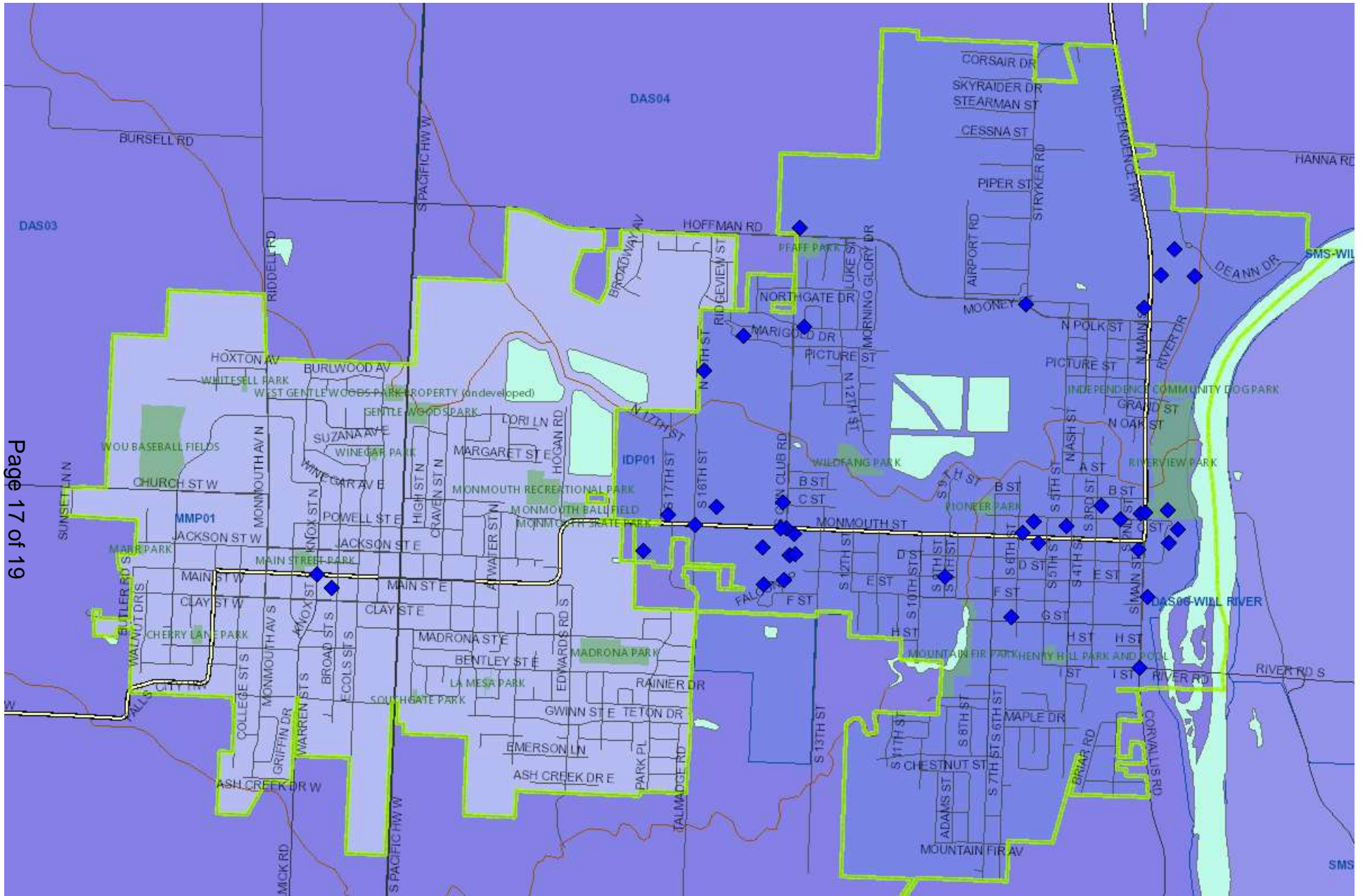

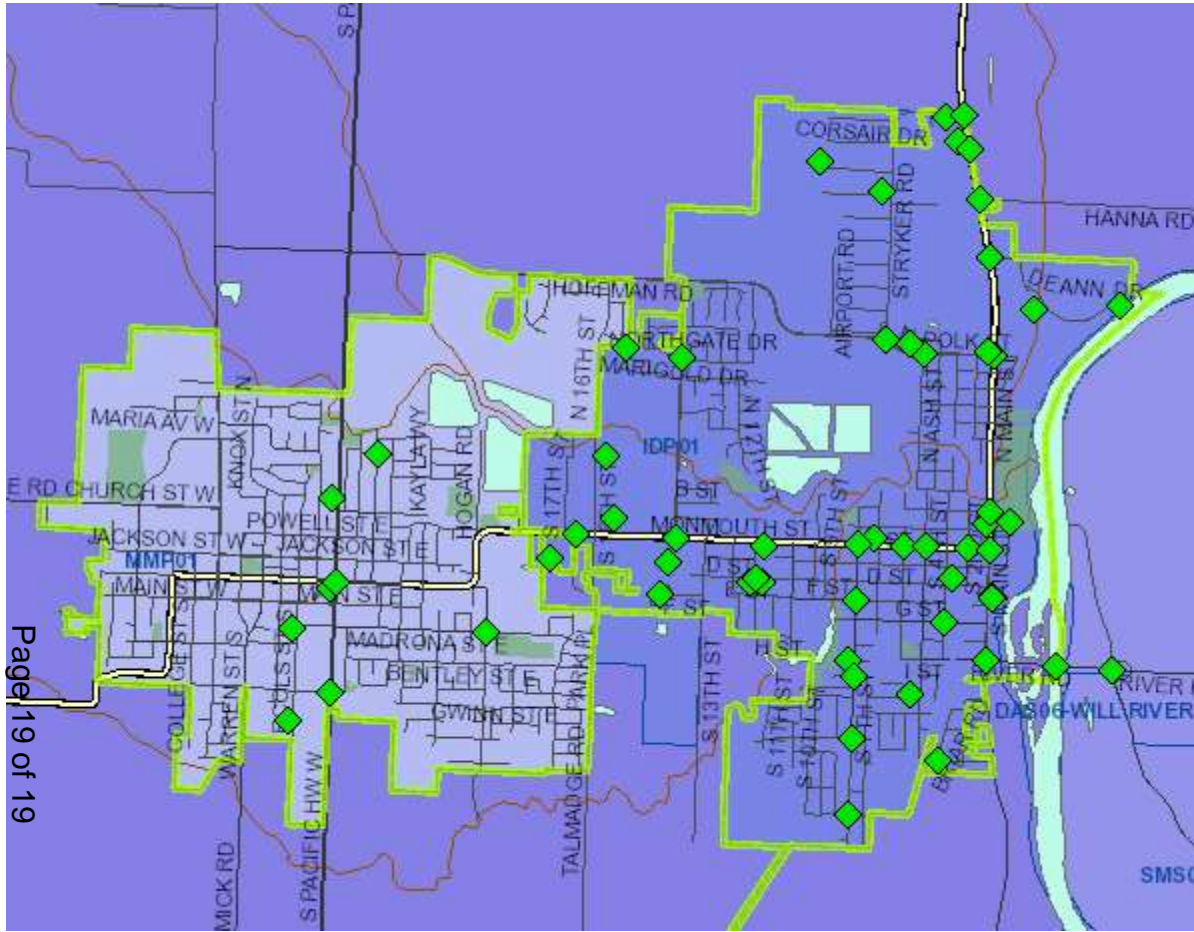
